The information systems curriculum prepares students for positions as decision support specialists, information systems specialists and systems analysts. Graduates of this program can pursue graduate studies in information systems, operations management, supply chain management or business. BSBA-IST majors are encouraged to gain practical work experience through internships, student organizations and community service. In addition, the Heavener School of Business offers students a wide variety of academic and career and leadership programs, including study abroad, the Florida Leadership Academy, involvement in student organizations and research activities. Students should consult an academic advisor/career coach for specific information. Requirements for the Major BSBA-IST majors must maintain a 2.0 core, major and UF GPA. Students must read the individual course descriptions in this catalog to determine the prerequisites for their required courses. Special emphasis is placed on understanding the links between various business disciplines and the development of sound business plans. Students will be able to effectively analyze a business entity's strengths and weaknesses as well as investigate the opportunities and threats present in the business environment. The information systems major covers computing, quantitative and application skills that can be used in a business problem-solving setting. Specific skill sets include database design, systems analysis and design, application of decisions support systems and the application of information systems strategies.
